AN ORDINANCE AUTHORIZING REPEAL AND/OR ELIMINATION OF THE SETBACK REQUIRE-MENTS FOR CERTAIN LOTS WHICH ARE ADJACENT TO DESIGNATED STREETS WHICH HAVE BEEN ABANDONED BY THE VILLAGE AND REVERTED TO THE HOLDERS OF SAID ADJACENT PROPERTY.

WHEREAS, on September 13, 1928, the Oakwood First Addition Plat was filed with the Clay County Recorder of Deeds at Book 5, Pages 66 and 67, wherein certain streets were laid out and certain setback requirements made for all those lot holders whose property was adjacent to the designated streets; and

WHEREAS, on June 13, 1952, the Village of Oakwood was incorporated under the provisions of Missouri law, which incorporated certain land as the Village of Oakwood, Missouri, including the land identified in the Oakwood First Addition Plat referred to above; and

WHEREAS, on July 13, 1954, under Ordinance No. 8, the designated streets within the Village of Oakwood as shown on the recorded Oakwood First Addition Plat which was filed with the Clay County Recorder of Deeds at Book 5, Pages 66 and 67, were vacated and abandoned, specifically all of Valley Road beginning at the north edge of Barnes Avenue and extending northerly approximately 305 feet to the south line of South Woodland Drive, all of Doniphan Lane beginning at the north edge of Barnes Avenue and extending northerly and westerly approximately 490 feet to the south line of South Woodland Drive. Said ordinance provided that title shall revert to holders of adjacent property, vacation to be divided equally to the holders of record as of that day.

WHEREAS, on March 28, 1955, Ordinance No. 10 was adopted by the Village of Oakwood which provided a comprehensive plan for the development of all real property within the Village under the Zoning Ordinance for the Village of Oakwood, Missouri, which repealed all prior ordinances in conflict with this Ordinance; and

WHEREAS, on February 12, 1976, under Ordinance No. 64, a certain portion of Poplar Drive, a public street designated within the Village of Oakwood as shown on the recorded Oakwood First Addition Plat which was filed with the Clay County Recorder of Deeds at Book 5, Pages 66 and 67, was vacated and abandoned, specifically that portion of Poplar Drive from South Woodland Drive to Barnes Avenue.

WHEREAS, no action has been taken by the Village of Oakwood to repeal the setback requirements as set forth in the recorded plat of Oakwood First Addition as they relate to those property owners whose property was adjacent to the then-designated streets as identified above which have since been vacated and abandoned.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF OAKWOOD,

CLAY COUNTY, MISSOURI, AS FOLLOWS:

All setback requirements created by the recorded plat of Oakwood First Addition which was filed with the Clay County Recorder of Deeds at Book 5, Pages 66 and 67, which setbacks were created as a result of those portions of Valley Road and Doniphan Lane, which have since been vacated and abandoned, are hereby also vacated and/or abandoned so that none of the above identified setback requirements now exist.

WHEREAS, on June 23, 1952, the Village of Oakwood was incorporated under the provisions of Missouri law, which incorporated certain land as the Village of Oakwood, Missouri, including the land identified in the Oakwood First Addition Plat referred to above; and

All set back requirements created by the recorded plat of Oakwood First Addition which was filed with the Clay County Recorder of Deeds at Book 5, Pages 66 and 67, which set backs were created as a result of the designation of those portions of Valley Road and Doniphan Lane, which have since been vacated and abandoned, are hereby also

vacated and/or abandoned so that none of the above identified set back requirements now exist.
